EXECUTIVE SUMMARY

The Commissioner has received an application for financial support from the Sophie Lancaster Foundation towards the cost of an event "Alternative solutions to tackling hate crime conference" to be held on 26 November 2014.

The application identifies that this conference meets the following PCC priorities:

- 1. Protecting vulnerable people
- 2. Promote targeted initiatives to contribute to tackling crime and re-offending
- 3. Champion the right of victims.

A contribution of £2,500 has been requested towards the total cost of the event (£4,753).

The request for funding was submitted as a request for support from the Community Action Fund and the application form is attached at Appendix A.

However, having considered the application it is considered more appropriate to provide funding from the Commissioner's Victims' Services budget rather than the Community Action Fund. It is also considered appropriate to provide a contribution to cover the full cost of the event of £4,753.

RECOMMENDATION

That the Commissioner agree to the contribution of £4,753 to the Sophie Lancaster Foundation to support the Anti-Hate Crime conference.

FINANCIAL IMPLICATIONS

The cost of the contribution of £4,753 will be contained within the Commissioner's 2014-15 budget for Victims Services.

SLF is organising the first Alternative Hate Crime Conference which will include key note speakers from The Home Office, Lancashire PCC, Police, CPS, Victims of Hate Crime and Education Specialists.

It also includes the launch of SLF's primary based educational resource.

The aim of the conference is to show how SLF works creatively in partnership with other agencies to tackle the damage hate crime does to our communities. E.g. Addressing young offenders directly about the victim impact of hate motivated crime. Delivering training to response officers to provide a clearer understanding of people from alternative subcultures and the extent of the violence they face.

It will showcase our work in education, with the police, NOMS and justice agencies. We will bring together victims, teachers and law makers/enforcers to demonstrate how our work is making a difference through education and training encouraging further partnership working. We will invite 150-200 people who through good practice can make a difference in our communities ensuring many additional people are reached.

This meets the PCC's targets of:

- 4. Protecting vulnerable people
- 5. Promote targeted initiatives to contribute to tackling crime and re-offending
- 6. Champion the right of victims.

Lancashire Police have just introduced "Alternative Subcultutre" as an indicator for hate crime. In response to the recently published report, Chief Superintendent Stuart Noble stressed the importance of victims feeling they can approach the police. He said: "It is unacceptable that in 2014 people are still victimised because they are perceived as being different.

"Interestingly this report has established that individuals are rarely targeted because of their religion but instead because of their appearance or behavior. Sadly children also feature amongst the perpetrators.

"Anybody victimised because of hostility towards them motivated by their religion, race, disability, gender identity or sexual orientation should contact police. It is important that all incidents of hate crime are reported. It is vital for us to know what is affecting the communities of Lancashire, so we can work with our partners to prevent these crimes and incidents that we know have such a big impact on the victims.

TERMS & CONDITIONS OF THE COMMISSIONER'S COMMUNITY ACTION FUND:

- 1. The maximum grant that can be applied for is £2,500, although the Commissioner will **normally** be looking for applications for less than this.
- 2. The Commissioner will not consider funding towards projects with a total cost of more than £10.000.
- 3. Organisations with unrestricted reserves of more than £10,000 will not be eligible for funding.
- 4. The Grant must be used for the project or scheme detailed on the Application Form and may not be used for any other projects or schemes.
- 5. If the full Grant is not used for the proposed project or scheme any underspend must be returned to the Commissioner's Community Action Fund.
- 6. The Commissioner will normally only consider one application per year from organisations or groups
- 7. A copy of the organisation/groups Constitution and latest Accounts <u>must</u> be submitted with the Application Form. Failure to do so may result in the Application being rejected.

SUCCESSFUL APPLICATIONS

1. If your application is successful you will be expected to provide bank account details for your organisation. Funding will normally be paid into the nominated Bank Account by BACS payment. In certain circumstances LANPAC may propose making payment direct to a service / equipment provider where this would be of benefit to the local group.

- 2. An Expenditure & Evaluation form will be completed by the Applicant either at the end of the financial year in which the Grant is made or at the end of the project, whichever is sooner.
- 3. The "Commissioner's Community Action Fund" logo should be used on all literature associated with the project or scheme and this should be credited as the funding source in all media and press releases. By accepting the Grant you will be agreeing to the Police and Crime Commissioner being able to use details of your project or scheme in publicity and media releases.
- 4. The Police and Crime Commissioner or a member of his Team will attend project opening or launch events where possible details of these are to be provided to LANPAC.
