Executive Summary:

- The Commissioner's budget for 2015/16 has been distributed to allocate £70k for Business Crime
- Within this umbrella of Business Crime Rural Crime is also considered
- This request seeks part funding for an educational handbook aimed at crime prevention for all farmers in Lancashire in partnership with LFRS/ambulance service/NFU
- The total cost of the booklet is £10k but the OPCC are being asked for part funding only to support the contributions made by the other partners
- If supported this leaves this would be a contributory cost of between £1500 still leaving over £65k in the Business Crime Budget

Appendix B

Lorraine Ellwood – Rural Policing and Wildlife Co-ordinator for the Constabulary has requested part funding support for a handbook in partnership with LFRS/Ambulance Service and NFU.

She has proactively engaged with the Office of the Police and Crime Commissioner (OPCC) and has met with the Commissioner on a number of occasions to share crime interventions taking place on the local and national agenda she has indicated that she has also verbally requested support from the Commissioner on this project.

She has indicated that the total cost of the handbook is £10,000 but that this cost is shared by the partners mentioned above. The police/OPCC are being asked to contribute £2,000 and Lorraine has confirmed that she can obtain £500 from LANPAC.

The handbook's circulation is aimed at getting the rural community to consider their own crime prevention measures. The circulation list is aimed at all farms in Lancashire. There is a photo of the handbook attached which indicates that amendments can easily be inserted without having to produce a new booklet each time.

An enquiry has been made in respect of OPCC branding and Lorraine has provided assurance that our branding can be on the products if purchased. She is fully supportive of this branding and would like to see further endorsement from the OPCC with a forward from the Commissioner in the booklet.

In view of the forthcoming wildlife Crime Awareness Week in October and a forthcoming national conference – it is important to keep Rural Crime high on the agenda.

It will also feature as part of the agenda/market place for the forthcoming business Crime Event sponsored by the OPCC in November.

The proposal has been discussed with both the Commissioner (Clive) and the Director (Angela) of the OPCC and support and approval has been received verbally for this booklet.
