# **Executive Summary:**

- 1. The Commissioner's revenue budget for 2015-16 includes an allocation of £2.288M for Community Safety and Partnership Funding.
- 2. In line with the approach agreed by the Commissioner the Victims, Partnerships & Commissioning Manager has held discussions with a number of partners regarding a range of proposed services and programmes which support the Commissioner's aims and priorities.
- 3. The Commissioner has received funding of £1,636,212 from the Ministry of Justice for victims services which includes £25,910 derived from the Prisoners Earnings Act.
- 4. This Decision seeks to confirm the allocation of £9,290 from the Community Safety and Partnership Fund to the projects, programmes and services detailed in Appendix B and £13,910 of the Prisoner's Earnings Act element of the Victims Funding
- 5. If this Decision is confirmed, there will be a balance of £521,777 remaining in the Community Safety and Partnership Fund for allocation against additional community safety activity.

#### Recommendation:

The Commissioner is recommended to approve the proposed use of the Community Safety and Partnership Fund as outlined in Appendix A and to note the implications in respect of funding that could be available for additional future community safety activity.

# <u>COMMUNITY SAFETY FUNDING 2015- 2016 – PHASE 2 AND VICTIMS SERVICES FUNDING PROPOSALS</u>

### **COMMUNITY SAFETY AND PARTNERSHIPS:**

# 1. INGOL AND TANTERTON COMMUNITY TRUST (INTACT)

INTACT are seeking funding to develop their work with 11-16 year olds and in particular to increase the activities aimed at girls in this age group. The funding would be used to provide equipment, resources and coaching sessions primarily for the girls.

The Ingol ward has high levels of deprivation and associated levels of ASB and criminal damage and has seen level rise in the last 12 months.

**Proposal:** That the Commissioner contributes £4,290 towards the cost of providing session for girls aged 11-16.

#### 2. CHORLEY STREET PASTORS

The Commissioner has previously approved an allocation of £20,000 to support Street Pastors across Lancashire during 2015/16 (Decision 2015/15). Chorley Street Pastors have requested funding to support the co-ordination of their teams in the Chorley area and to develop a training and promotional video.

**Proposal:** That the Commissioner contributes £5,000 towards the cost of coordination and training resources for the Chorley Street Pastors.

### **VICTIMS FUNDING**

#### 3. PRISONERS EARNING'S ACT FUNDING

The Prisoners Earning Act (REA) funding of £25,910 is included in the victims grant funding from the Ministry of Justice. The funding has previously been used to enable victims services to provide immediate help and support through items such as home and personal security measures, food vouchers or short term financial assistance

**Proposal:** That the Commissioner provides £13,910 from the PEA funding to Victims Support to provide a range of immediate help and support to victims including the items detailed above.
