Summary:	Following consultation with the refugee community in which swimming was highlighted, Inspiring Grace have worked with the local leisure centre to develop a swimming session's project. Inspiring Grace will deliver three 10 week sessions targeting up to 90 (30 per 10- week period) vulnerable women.				
Comments:	Inspiring Grace have strong links with the refugee community. Pendle Leisure Centre have agreed to run the sessions outside of usual opening times with female only life guards, coaches and staff. The local police will also attend sessions to establish links with the community.				
Recommendation:	 That this application is supported by the Commissioner. That a grant of £3,000 is provided to Inspiring Grace.

Summary:	Park View 4U have developed a six week pilot project to engage young people at the risk of offending. The project will provide young people with the opportunity to learn a range of outdoor skills from woodcraft to outdoor cooking.				
Comments:	The park suffers from low level crime and anti-social behaviour and therefore the group work in partnership with local officers who will support the project. The group also work closely with the local school who will be able to identify and refer vulnerable youngsters into the scheme.				
Recommendation:	 That this application is supported by the Commissioner. That a grant of £1,674 is provided to Park View 4U.
