Executive Summary

- 1. The Commissioner's revenue budget for 2019 20 includes a funding allocation to support projects within Counter Terrorism. This application relates to a request for funding from Blackburn with Darwen who are the host authority for Prevent.
- 2. Prevent forms part of the Government's Counter Terrorism strategy CONTEST which aims to safeguard and stop people from becoming terrorists.
- 3. This application is supported by wider Home Office funding and fits in with the objectives of Prevent.
- 4. The scheme aims tackle, support and safeguard those individuals most vulnerable and at risk.
