Executive Summary

- 1. The Commissioner's revenue budget for 2019 20 includes a funding allocation to support the two Make Every Adult Matter (MEAM) schemes across Lancashire. This application relates to a request for funding from Blackburn with Darwen.
- 2. The Commissioner invited applications from Blackburn with Darwen Community Safety Team that supported the ongoing work of the outreach facilities that support those vulnerable adults who present to agencies with the most complex of needs and demand on services.
- By piloting the Stay Safe initiative in Darwen it is hoped that by encouraging young adults to engage in this scheme it will support the community and the vulnerable adults alike whilst working alongside the relevant agencies and the Special Constabulary.
- The scheme aims to remove vulnerable children into places of safety and into police protection.

Recommendations

The Commissioner is recommended to approve the request for £10,000 from the Crime, Reducing Reoffending & Criminal Justice Budget.
