TITLE: DRUG AND SUBSTANCE MISUSE FUNDING - BLACKPOOL

Executive Summary

- 1. The Commissioner's revenue budget for 2019 20 includes a funding allocation to support drug and substance misuse services across Lancashire including a provision Lancashire County Council (LCC) and for the two unitary authorities Blackburn with Darwen (BWD)and Blackpool Councils.
- 2. The Commissioner invited applications for funding to be submitted from the Public Health Specialists within Councils for services that supported and complimented existing wider services around peer support and mentoring
- 3. Blackpool Council have submitted an application which seeks to support individuals in structured schemes of support including training for staff and supported interventions to prevent harm.
- 4. This Decision seeks to confirm the allocation of £78,000 from the Tackling Crime and Reducing Reoffending Fund to Blackpool Council.

Recommendations

The Commissioner is recommended to approve the proposed use of the Reducing Reoffending Fund as outlined in Appendix A.
