## **EXECUTIVE SUMMARY**

- 1. The Commissioner has approved the budget for 2014 15 (Decision 2013/41) which includes an allocation of £1.794M for Community Safety and Partnership activity.
- 2. The Commissioner has access to the Proceeds of Crime Funding and will determine any spend of funding secured in excess of £680,000.
- 3. The Commissioner has been successful in securing £545,000.00 from the Victims Competed Fund from the Ministry of Justice. This funding is for the further support of the victims of domestic abuse and child sexual exploitation.
- 4. Constabulary officers and staff, along with partners are involved in, or have developed, a number of projects and programmes which are outside of the core policing activity. Funding for these is sought from a range of partners and organisations including the Commissioner.
- 5. Applications are assessed against the Commissioner's Aims and Priorities, how well they represent value for money and how they will support core policing activity. The presence of any match funding or matched resources is also taken into account.
- 6. The Commissioner's 2014/15 revenue budget for Partnership & Community Safety activity has £436,039 available for spending and the balance on the POCA reserve at 31 March 2014 was £554,270.

- 1. The Commissioner considers the applications in Appendix A.
- 2. The Commissioner approves the following:
  - The allocation of £98,654 from the 2014/15 revenue budget for Partnership and Community Safety activity for the following projects:
    - Making Every Adult Matter (MEAM) £96,854
    - > Taxi Pre-payment scheme £1,800
  - The allocation of £17,000 from the POCA reserve for the following projects:
    - National Ugly Mugs scheme (NUMs) £7,000
    - Parades and Community Events, Road closure training for stewards £10,000
