## 'Appendix B

Jane Binnion approached the Office of the Police and Crime Commissioner in may of this year and originally sought to seek financial backing from the Community Action Fund. She was redirected to myself in relation to the Crime, Re-offending and Criminal Justice Portfolio. She visited the office and outlined her proposals – which were to educate parents in schools about social media and the other platforms available to children. At this time we were gathering proposals for consideration for POCA.-

In meeting Jane she recognised that to some degree there is an element of 'ostrich' syndrome amongst parents who have bought the phone, tablet, computer for their child. She wishes to skill up and empower parents to discuss issues with their children and encourage debate.

Young people and parents will benefit from the delivery of this project by understanding the impact of their actions and being able to have dialogue with adults about their concerns.

Schools are required to provide one day per school year for parents to receive training regarding the dangers of social media and the awareness that the implications of students actions can have repercussions in later years affecting employment, university placements and gap year travels.

Jane wants to protect the front line police resources by diverting resources from schools and negating the need for officers to be called to schools at the same frequency and it is hoped to reduce the number of bullies on line and protect those who have felt bullied.

In looking further into Jane's request we have met with Graham Lowe who works for the Children's Safeguarding Board providing training on all matters ICT. He is aware of the provision of these packages to parents from schools and the requirement for one day input. He also informs that there are a number of these packages being delivered but the workload is vast and supports growth in this area.

Following the POCA meeting this application was supported but in other funding streams and in meeting Jane to confirm further information we have urged that she work with Graham Lowe in respect of continually updating the package provided, consider appropriate times for maximum exposure for the delivery of the product ie Christmas and end of summer term when devices are likely to be purchased or used more frequently and to consider how to encourage the attendance of parents working with our own publicity via website and schools forums etc

Jane will use our branding and invite the office to her input and look for the PCC to open an event.
