TITLE: FUNDING FOR BRAKE'S NATIONAL ROAD VICTIM SERVICE

Executive Summary

Brake is a national charity which supports the families of those killed or seriously injured in road traffic collisions.

The charity has received funding from the Depart for Transport for approximately onethird of the cost of its National Road Victim Service, and is now asking PCCs to contribute funding toward the shortfall.

The service comprises of support packs which Family Liaison Officers (FLOs) give victims and their families, as outlined in the College of Policing standards, professional training for FLOs, and a helpline which families can self-refer to or be directed to by their FLO. Currently, families of road traffic victims are not automatically referred into commissioned support services unless a crime has been committed.

In 2019/20, the charity supported 13 road crash cases in the county. Brake estimate it provides £3,000 worth of support to each case in cost avoidance for police and "significantly" more for wider public service. Research by Brake indicates without specialist support there are additional costs to society such as post-traumatic stress disorder, inability to work, family breakdown and addiction.

The total service cost in Lancashire is £11,488. Brake is requesting a contribution of £3,000 from Lancashire Police and Crime Commissioner toward its service for 2020/21.

Recommendation

The Commissioner agrees £3,000 of funding for Brake for 2020/21, to be reviewed at the end of the financial year.

Financial Implications

The service is a co-commission, in line with commissioning guidelines. In co-commissioning, the Commissioner acts as a contributor of match funds or in kind support, in order to deliver outcomes.
