TITLE: VIOLENCE REDUCTION NETWORK AND COMMUNITY SAFETY PARTNERSHIP FUNDING 2020-2021

Executive Summary

The Home Office has provided grant funding to the Lancashire Police and Crime Commissioner for 2020-2021 from the Police Surge Grant and the Violence Reduction Grant Fund to continue funding the delivery of the local Violence Reduction Unit, in Lancashire identified as the Violence Reduction Network.

This decision seeks to confirm the allocation of the Violence Reduction Unit grant and the Police Surge grant.

The Commissioner has approved the budget for 2020-2021 which includes an allocation for Community Safety & Partnership Funding.

This decision also seeks to confirm the allocation of £240,000 to the 12 district Community Safety Partnerships as outlined in Appendix A and maintain the funding allocated to the two unitary areas; Blackburn with Darwen (£70,000) and Blackpool (£91,000).

Recommendations

The Commissioner is recommended to approve the allocation of the Violence Reduction Unit grant as outlined in Appendix A.

The Commissioner is recommended to approve the allocation of the Police Surge grant as outlined in Appendix A.

The Commissioner is recommended to increase the funding allocated to the district Community Safety Partnerships from £10,000 to £20,000 for projects / initiatives that support the Police and Crime Commissioner's priorities as well as the four VRN priority areas outlined in Appendix A.

In 2019 the Home Office provided funding to Lancashire to establish a Violence Reduction Unit. For 2020-2021 the Home Office has continued to provide funding towards the delivery of the local Violence Reduction Unit.

The Commissioner allocates funding to Community Safety Partnerships (CSPs) for projects / initiatives that support the Commissioner's priorities as well as their local CSP priorities.

For 2020-2021 the ambition is to encourage CSPs to work closely with the police and Violence Reduction Network to tackle serious violence by increasing their allocation to £20,000.
