Executive Summary

The Commissioner's revenue budget for 2020/21 includes an allocation of funding in respect of Priority 2 – Tackling Crime and Reducing Reoffending.

In 2019 following an initial advisory group including Public Health England report advising on the concept of a local drug alert scheme (LDIS) such a scheme was introduced with contributing partners of the PCC, LCC, BWD and Blackpool.

Funding this scheme has proved invaluable to all partner agencies to receive strategic professional information that demonstrates more than just the patterns and trends of drugs available. It has also provided advice in respect of treatment and support for those individuals who present themselves with complex needs and are homeless in respect of Covid19 precautions in addition to warnings of dangerous drugs being made available.

It is therefore requested that the Commissioner contributes £2500 for a further 12 months in line with the other authorities to maintain this invaluable service.

Recommendations

The Commissioner is recommended to approve the proposed use of the Reducing Reoffending Fund.

PART I

1. Background and Advice

In January 2016 an advisory group working with Public Health England produced a report entitled 'Drug Alerts and Local Drug Information Systems' and supporting a Local Drug Information System (LDIS). An agreed LDIS uses consistent and efficient processes for sharing and assessing information and issues warnings where appropriate.

In 2019 such a system was set up for Lancashire for contributions from the PCC, LCC, BWD and Blackpool council to support such a scheme for Lancashire. All agencies have been in receipt of immediate strategic advice in respect of drugs flooding the vulnerable community, the medical advice to support care and withdrawal together with more recently key advice in respect of the treatment for our most vulnerable individuals with complex needs in line with Covid19 conditions.

Since the initial implementation this scheme has been able to move to a multi -agency systematic approach and a further year's contribution of £2,500 would see this work continuing.
