<b>Summary:</b>	<p>The Youth Leadership Project will target young people aged 10-20 involved in anti-social behaviour. Young people will take part in a range of online and classroom sessions to become a youth leader including confidence building, presentational and communication skills. Young people will have the opportunity to put their skills into practice with the archery club and deliver sessions to primary schools.</p> <p>Young people also volunteer at the foodbank and weekly curry club.</p>

Mentors aim to address and help young people address issues such as family, relationships, bullying and housing. Fishwick Milan work in partnership with the local mosque, schools, youth offending teams, social services, probation and the local police.
