### 1. Background and Advice

In March 2016 (decision 2015/85) the Commissioner approved a Combination Agreement to establish a Combined Community Safety Partnership for Blackburn with Darwen, Burnley and Rossendale Council areas, to be known as the Pennine Lancashire Community Safety Partnership

Hyndburn Borough Council have now requested to formally join the Pennine Lancashire Community Safety Partnership.

Under Schedule 11 (Section 5A) of the Police Reform & Social Responsibility Act 2011 the Police and Crime Commissioner has the responsibility to approve a Combination Agreement between two or more Community Safety Partnerships (CSP)

To approve a Combination Agreement the Commissioner needs to be satisfied that the Combination Agreement evidences that it would be in the interest of one or more of the following to do so –

- (a) Reducing crime and disorder
- (b) Reducing re-offending
- (c) Combating the misuse of drugs, alcohol and other substances
- And that all responsible authorities in relation to the area are party to the agreement.

The evidence is outlined in Appendix B.

#### 2. Links to the Police and Crime Plan

The Commissioner is committed to support and work in partnership with all the Community Safety Partnerships across Lancashire.

The Commissioner allocates funding to each district Community Safety Partnership for projects and initiatives that support the Commissioner's priorities.

#### 3. Consultation

All the statutory community safety partners detailed in appendix B have been consulted and support Hyndburn Borough Council to formally join the Pennine Lancashire Community Safety Partnership.
