SUMMARY:	AFC Fylde Community Foundation wish to target young people (8-16yrs) who have witnessed or been subject to Domestic Abuse with their project Our Time. AFC Fylde will work with schools to identify young people through Operation Encompass and work alongside Lancashire Police, Fylde Borough Council, Blackpool Councils Public Protection Team, and Nest Lancashire. The funding is for delivery of five, twelve-week cohorts for a minimum of 50 young people (2-hour weekly sessions at a school venue – afterschool timeslot). The workshops will include, improving resilience and emotional wellbeing, safety planning in the event of Domestic Abuse and understanding Domestic Abuse and emotional wellbeing.

Young people will be able to access a range of activities, educational workshops and support on mental health and wellbeing. Larches and Savick PACT have a close working relationship with the local police who identify young people participating in negative risk-taking behaviour and refer them into the sessions.

SUMMARY:	Blackpool FC Community Trust deliver services in hotspot locations identified by the Police and Community Safety Teams. Tower Above is a one-to-one mentoring programme that works with young people aged 8-12 who are at risk of and/or involved in ASB/crime with referrals coming from Blackpool Council's Early Help & Support team. The programme adopts a multi-agency approach in order to support the young person to make positive changes. The funding would be to enhance their offer, enabling their mentoring staff to attend PL Kicks sessions in the evenings to identify more young people who would benefit from one-to-one support/mentoring due to negative behaviours they are displaying in the community. This would involve staff engaging with young people, providing impartial information, advice, and guidance on topics such as knife crime, substance misuse and general ASB. Young people who they identify as needing one-to-one support, will be offered a maximum of 20 mentoring sessions which use sport as a vehicle to engage and provide interventions.

SUMMARY:	Criminal exploitation has become an increasing threat to the young people of West Lancashire due to the surrounding areas. Gangs are using children, some as young as 12 to move / sell drugs. West Lancashire CSP would like funding to deliver the Choices 24/7 programme in schools across West Lancashire. The programme which focuses criminal exploitation, the signs and how to make positive choices is delivered by an ex-gang member and a mum of two young men currently serving team for drug / violence related offences. We Are With You, young persons substance misuse services will deliver a follow up session on drug / alcohol support. The Lancashire Violence Reduction Network funded a pilot session for a school which received excellent feedback on how the hard hitting approach worked well.
