## **Executive Summary**

The Commissioner has provided funding for the provision of grants to enable activity that supports the delivery of his Police and Crime Plan.

The 'Safer Lancashire Neighbourhoods Fund' includes the 'Community Fund' which provides grants of up to £10,000 to deliver activity that will address one or more of the Police and Crime Plan priorities:

- Getting tough on Anti-social behaviour
- Disrupting and dismantling organised crime
- Tackling domestic abuse and sexual violence
- Cracking down on burglary and robbery
- Targeting dangerous drivers

The Police and Crime Commissioner received 11 applications to the Fund in October 2022.

This report sets out the proposed treatment of these 11 applications for funding.

- 5. West Lancashire Borough Council
- 6. Bahja Initiative

Of the 11 applications received 3 are proposed for approval totalling £7,332 and 2 applications are proposed for approval subject to specific conditions, totalling £7,000. Further details of the applications for which approval is proposed is set out in Appendix A.
